

## Henry Adkins Smith

Henry Adkins Smith died at the home of Mrs. T. H. Johnston at Stillwater, Colorado on Sunday, October 20, 1918, aged 34 years, four months and twenty six days.

Henry Adkins Smith was born May 24, 1884 at Hot Sulphur Springs, Colorado. He was the son of P. H. Smith, one of the pioneer residents of Grand County. He grew up to manhood and received his education in public schools. He was one of a pair of twins, Preston A. Smith, the other twin and elder of the two, was killed by having a horse fall on him near the Troublesome, May 28, 1908. His mother died when he was five years of age and very early in life these two boys went out in the world for themselves, and until the time that Preston was killed they always stuck together.

For a good many years Henry has made his home at Stillwater and called Mrs. Johnston mother. He was a successful ranchman and had considerable stock.

When he was younger, both he and Preston were the crack riders in the county, and there was a great deal of controversy amongst their friends as to which one was the better. Late years since he was operated on for appendicitis he had to quit the riding game. He was for several years the main man at the Grand Lake Stage Company, and was widely known as an expert horseman.

Henry made three different attempts to join the army, but was refused on the account of some trouble with his heart. Having been drafted he was making every effort to go with the first Class A men of the new draft.

His death was due to pneumonia, the result of influenza contracted while shipping cattle to Denver three weeks ago. He is survived by his father, P H Smith of Grand Lake, Mrs. W J Thompson of Hot Sulphur Springs, Mrs. Georgia Eslick of Grand Lake, Mrs. Ralph Steinhardt of Elkhorn, Wisconsin, Mrs. Geneva Masterson of Aberdeen, SD and one brother, Edward B Smith of Grand Lake.

Henry was buried at Hot Sulphur Springs beside Preston, Tuesday, October 22<sup>nd</sup>. The funeral was conducted by Rev. W. R. Hodges, the same minister who performed the service for the other brother, ten years ago.

Henry Smith was a self made man in the truest sense of term. The best evidence of his worth is the testimony of his friends that he was honorable, clean and straight forward; that he never failed to lend a helping hand to anyone in trouble or in need, and that he is mourned like a brother by many who had no blood relationship with him.

Henry Smith of Stillwater was taken to St Luke's Hospital in Denver on last Tuesday evening's train, a victim of that dreaded modern day luxury, known as appendicitis. An effort was made by Dr. Rawls to convey him to the hospital on Friday afternoon of last week, but on account of the blockade on the railroad the train was turned back from Ranch creek and Henry was taken to Hot Sulphur Springs where he was taken care of and made as comfortable as possible until Tuesday afternoon. The operation was performed about 11 o'clock Wednesday morning. At 12 o'clock noon of the same day it was stated that Henry had about an even chance for recovery. With his iron constitution, Henry's many friends in Grand County hope and believe that he will survive the ordeal and be fully restored to his normal health.
