# GRAND LAKE AREA HISTORICAL SOCIETY Annual Report July 14, 2021

#### Nominations to the Board

The three-year terms of Steve Batty, Jim Cervenka and Ken Fucik have been completed at this time. Steve, Jim and Ken have agreed to continue as board members, leaving one vacancy for the term expiring this year. Additionally, Keith Kratz has had to retire from the board, leaving a second vacancy. Board member Frank Reardon will present nominees for open Board positions at the GLAHS Members' Annual Meeting following the public presentation. The GLAHS Board is truly a working group of volunteers, and we are very grateful to those who have given of their time but must leave the board, as well as those stepping up to fill open seats. The Board of Directors meets at 7:00 pm on each second Wednesday of the month. Meetings are generally held at the modular office facility, 610 Center Drive, just south of the post office. The offices, President, Vice-President, Secretary, Treasurer, are filled by sitting board members.

#### **Property Maintenance**

Old buildings, especially those that attract visitors from around the world, need consistent care to keep them sturdy and welcoming. Keith Kratz has served as Property Maintenance Chair, with considerable support from Ken Fucik, Jim Cervenka, Dave Sauer and others during this turbulent last year. There have been projects large and small to keep the Historical Society buildings in good condition. At the Kauffman House, it was determined that baseboard heaters already installed did not



need replacement, minor repairs were needed for the House's water heater when electricity was turned back on following fire evacuation, a survey and inventory of lights and supplies for them was conducted, and the House's furnace was monitored, as were the security systems. Keith plowed snow at the modular office and Kauffman House parking areas. Thanks to Karen Rempel who keeps the interior of the House clean and looking good.

and temporarily cover the roof of the Eslick Store and Office (ESO) building, slated to eventually be a welcome center. Keith also alerted the board to a tree leaning toward the ESO, and Hoppe Southway volunteered to remove the tree, for which we are grateful.

#### **Collections and Accessions**

Kathy Means serves as Collections Manager. Items added to the collection in the past year include a couch and chair from the Week's cabin on the lake, donated by Scott Munn and displayed in the

Kauffman House parlor; the kitchen features a 1911 vacuum donated by Kathy Weydert.

In the general collections are now six photograph scrapbooks donated by Fran Needham that once belonged to her mother, Caroline Pratt Holzwarth, a valuable addition to the history of the early 1900s life in Rocky Mountain National Park. Other

additions to the collections include ski gear used by the 10th Mountain Division in World War II donated by Larry Bacon, many more Sanborn postcards donated by members following last year's Sanborn Postcards annual meeting presentation, posters and a large panoramic photograph of Grand Lake and the tourist



boat Mickey brought to us by Michael Elliott, and numerous photos and newspaper articles donated by Chris Rourke in recognition of the Spitzmiller family and Grand Lake Plumbing's

100 years of operation. Special thanks to Guy Allmeyer and his sister Susan for sharing movie theater items for this year's annual meeting, which will become a permanent display in the Community House.

The Cottage Court Museum has added many items donated by Steve Batty, including fishing gear and clothing from both the 1915-1930 era of the Court, as well as items to be displayed in the 1935-1960 period rooms at the site.

A special exhibit, celebrating the 100<sup>th</sup> Anniversary of the opening of Grand Lake Lodge, was featured at the Lodge in 2020. Items for the display were loaned by Grand Lake Lodge, Bob Scott, Suzanne Silverthorn, Kate and Doug Means, and Martha Boehner. Grand Lake Lodge history, including a film, as well as 100th Anniversary celebrations of the completion of Fall River Road in Rocky Mountain National Park and the Circle Tours through the Park are on special exhibit in the Gallery of the Kauffman House Museum. Books for each of these Centennial exhibits are available in the House Gallery and on the GLAHS website, www.grandlakehistory.org. It's all pretty amazing, and well-worth visiting. Volunteers assisting with displays and exhibits, including the

holiday decorations, include Deb Bondi, Sandia and Bill Bruton, Elin and Jim Capps, Julie and Joe Cunningham, Bob Means, Kate Means and Patti Stahl.

Research projects in the past year include efforts to update our vast "Ranches" materials following the East Troublesome Fire damage or destruction. Several projects are in progress to research, and preserve or rehabilitate local historic signs: the AA Barn, the iconic Humphreys sign, and information about the sign originally located at the Miyauchi's Snack Bar.

The Grand Lake Area Historical Society has worked with the Grand Lake Yacht Club to develop systems for




digital archival of Yacht Club memories, particularly video and audio interviews. This material will strengthen Historical Society historical information, and will offer additional layers of security for Yacht Club precious memorabilia. Thanks to Mary Beth Lagerborg, Elin Capps, Jim Cervenka, Kathy Means and the Grand Lake Yacht Club for their hard work and persistence.

## **Cottage Court and Smith Eslick Cottage Camp**

Projects galore at the evolving Cottage Court Museum and its surrounding site! A second interpretive panel, this one describing the CBT Project and the origins of Grand Lake, is now along the remnants of the Cairns #3 Ditch along Vine Street; built by Traub Design Inc, it was installed by Jim Cervenka.

A 1929 Model A Ford is now displayed in a museum carport, thanks in good part to Dave Sauer who located the car and, with Joel Rogers, transported it to the site. Paul Harrington and his crew assisted our volunteers to settle the





refurbish this display: new upholstery, window cranks, and the like.



Soon to come will be "Object Theaters", featuring motion sensor audio and directed lighting with a Clyde Eslick figure seeming to speak in each of two guest rooms in the Cottage Court. These are made possible by very generous donors, and grants from the Grand Foundation and Grand County.

We thank Good-to-Go Portables for donating a restroom at the site, and Jim Capps for building corn hole and building sets for kids of all ages to

play with. George Davis, with R&R Electric, put in an electric outlet which made possible connecting both the Object Theater devices as well as a security system. We still are working to find an efficient way to accept credit cards; admission is presently by donation, and few people carry cash anymore.

Two new "Cottage Court Museum" signs seem to be helping visitors find this new museum; it's a mostly outdoors or very well-ventilated site, so people are comfortable there even with residual COVID concerns.

Meanwhile in the past year, at the Eslick Store and Office (ESO), the small building with a bay

window adjacent to the Cottage Court, there has been a lot of progress as well. With a grant from History Colorado-State Historical Fund, we have completed a Historic Structure Assessment which indicates that, despite its decrepit façade, the building can be rehabilitated. We had hoped to obtain funding to construct a permanent foundation under the ESO last year, but that didn't happen. We did, however, earn a second grant from SHF which, with additional support from the Town of Grand Lake, will result in our having complete engineering and architectural construction plans ready to go as we search for funding to rehabilitate the building as a welcome center/gift shop/restroom.



Future plans still include development of a community events site on the lot just west of and adjacent to the Cottage Court: building a shelter with fire pit and equipment for historical presentations and fun stuff, as well as installation of more historical exhibits.

#### **Finance**

The Finance Committee presently includes Treasurer Patti Stahl and Board Member Frank Reardon, with occasional support from Jan Knisley of Edward Jones. The committee monitors the GLAHS finances overall, advises the Board, and continues to revise and update policies and records systems as needed.

#### Gardens

Lois and Dave Sauer have been working intensely and almost daily to reinvigorate the gardens and landscaping at the Kauffman House and the nearby Pioneer Garden. Using the original landscape plans for the area, they have weeded, taken out invasive and out-of-control bushes, trees and other plants, and have added necessary and lovely replacements. They have received support from the Town maintenance team who often come by to pick up the bags and piles, and have donated mulch. If you'd like to help, contact the Sauers at dbsauer57@gmail.com.



#### Visitation

Remarkably, during the past year of COVID restrictions, visitation at the Kauffman House Museum nearly approached the annual average, with visitors from a handful of foreign countries, many states and, as usual, most from Colorado. Visitation at the Cottage Court Museum is steadily increasing as more people hear about the site. Geocaches draw visitors at both museums, and are updated and monitored by Joe and Julie Cunningham.

Carol Goscha is the web master, continually adding information to our website, www.grandlakehistory.org. Materials that were once only accessible in person at one of our museums can now often be enjoyed online; notebooks displayed at the Kauffman House Gallery "Hunters and Trappers", "Ranchers" located in the Events section of the website, and information about people such as the brothers Wiswall who were photographers and tavern owners. Also on line is a virtual tour of the museum and individual pictures of items in our collections. Check it out!

In the past year, we distributed brochures advertising the Kauffman House and Cottage Court Museums, included an article about Grand Lake's history for the recently published *Grand Lake Guidebook*, mailed an annual printed newsletter to over a thousand mailboxes, and updated news of events for local newspapers and online media. More simply, but effectively, we continue to advertise events in window posters and on the chalkboard at the Kauffman House.

#### Office

With support of a generous donor, we were able to replace a computer that suffered complete power failure in the past year. Thank you so much! We also networked our PastPerfect museum software program so that more than one volunteer staff member can work at a time. Heather Bishop and Ken Fucik were particularly helpful with this upgrade. The GLAHS office at 610 Center Drive is a very busy place, and these equipment changes were very necessary indeed!

The Grand Lake Area Historical Society supports the work of the Grand County Creative Coalition with their many projects, including Space to Create, construction of a new marquee in Town Park, and rehabilitation of the Grand Lake Community House. An additional 19 non-members were present for the presentation only.

President Jim Cervenka welcomed the attendees. He thanked those who set up the venue. He discussed facets of the all-volunteer Grand Lake Area Historical Society: the geographic boundaries in which we work to protect, preserve and promote the history of the Grand Lake area, our collaboration with other county historical groups in the Heritage Coalition, the Kauffman House Museum's 46 years welcoming and educating visitors, and the importance of volunteers in enriching the visitor experience at the Kauffman House Museum..

Jim then introduced the evening's presenter, John Meissner who spoke about and with a PowerPoint presentation, "The Sanborn Collection of Grand Lake Photo Postcards". John began by explaining that Harold Sanborn made photo postcards of many locations in Colorado and elsewhere, and that these photo postcards are quite often the only visual evidence of aspects of a locale's history. He emphasized that Sanborn made real photo postcards on photo paper, not lithographed and colored facsimiles, which sold originally two for 5¢. Sanborn was known to print a few at first, put them in a retail location, and then send the photo to a publisher to make many more if they appeared to be popular sales items. John explained that the history of the life of Harold Sanborn is difficult to research as there is no immediate family left, and Sanborn and his family kept absolutely no records of his work. It's thought that Sanborn died in about 1963. John explained that a collector of these postcards needs to look for the view shown, generally a horizontal presentation without date markers or people in the scene so the card would never seem outdated and could keep selling. The collector also needs to look for one of the several genuine Sanborn signatures at the bottom of the card, for the title which would generally be in all capital letters, and an alphanumeric code of Sanborn's invention. Grand Lake cards are part of a series coded with "G"; cards with numbers 1 through 152 are the very rarest Grand Lake cards. It's noted that after 1933, codes became simply numbers greater than 750, and without an alphabet letter. Some postcards are extremely rare as very few were printed; 70 cards in the "G" series were produced in a batch of 100 or less. Sanborn built the largest independent postcard business in Denver at the time, beginning first as Sanborn Magazine Service before 1922, then Sanborn Souvenir Company after 1925.

After a brief intermission with cake served, GLAHS members conducted the business portion of the Annual Meeting at 8:20 pm. Patti Stahl moved, Ken Fucik seconded, all agreed to accept the minutes of the 2019 Annual Meeting. President Jim Cervenka discussed the urgent need for more volunteer participation in the GLAHS, particularly as tour guides at the Kaufman House Museum (contact Frank Reardon) and the Smith-Eslick Cottage Court Museum (contact Elin Capps).

Jim explained that the three-year terms of board members Elin Capps, Frank Reardon, Patti Stahl, and Mark Mix are completed this year; Elin, Frank and Patti have agree to continue on the Board. Additionally, board member Deb Bondi has resigned as she has moved out-of-state. There are now two vacancies on the Board. Nomination Chair Ken Fucik said that it was difficult to find folks able to serve, but was very pleased to recommend two nominees: Lucy Fitch who has long been supportive of our area history and particularly the Cottage Camp, and Keith Kratz who has been involved in several community activities and who is willing to become the Property Maintenance Chair. (Applause) As there were no nominations from the floor, Kathy Means moved we elect Keith Krantz, Lucy Fitch, Elin Capps, Frank Reardon and Patti Stahl to the Board; Sandia Bruton seconded, all agreed. Jim thanked Ken Fucik for his service.

As most members of the board were in attendance during and despite COVID 19 concerns, Jim asked for a motion to approve the officers, Jim Cervenka as president, Kathy Means as Vice- President, Elin Capps as Secretary, and Patti Stahl as Treasurer, all of whom agree to continue in their positions. Ken moved we approve this slate of officers, Patti seconded, all board members agreed.

Jim again asked those present to consider volunteering as tour guides at one of the museums, or in any of the GLAHS projects. He said that the next board meeting, always open to the public, will be August 12th, either in-person at the GLAHS Modular Office, or via Zoom. Jim thanked everyone for coming; Steve Batty moved for adjournment, Ken seconded, all approved; meeting adjourned at 8:40 pm.
